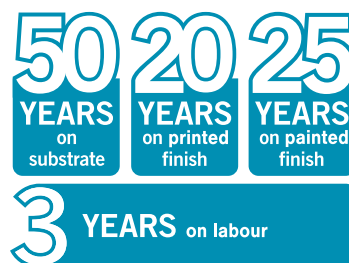

# Limited Warranty Extruded Aluminum Planks

## Maibec Dizal™ Aluminum Cladding Extruded Profiles | Printed Finish | Paint Finish



WARRANTY APPLICABLE IN CANADA TO PRODUCTS SOLD THROUGH MAIBEC INC.

### SECTION 1 - EXTRUDED ALUMINUM PROFILES

(The term "PRODUCT" refers to the extruded aluminum profile. It excludes any finish or material applied to it).

Maibec Inc. expressly warrants that its extruded aluminum products are free of physical and manufacturing defects.

During the warranty period, when the PRODUCT is installed and maintained according to Maibec Inc.'s instructions, it is guaranteed against the following:

- 1.1 **Warping.** The PRODUCT is free of warping, except for warping due to the structure or mounting surface on which the PRODUCT is affixed. For the purposes of this warranty, warping is defined as a deformation exceeding one sixteenth of an inch (1.6 mm) out of plane per linear foot (304.8 mm).
- 1.2 **Corrosion.** When installed and maintained according to Maibec Inc.'s instructions, the PRODUCT is also warrantied against rust and corrosion. Subject to the limitations set out in Section 4.
- 1.3 In the event that the PRODUCT has a physical or manufacturing defect during the warranty period, Maibec Inc. agrees, at its sole discretion, to repair or replace the defective portion of the PRODUCT.

### SECTION 2 - PRINTED FINISH

(The term "FINISH" refers to the primer coat, the high-definition printed coat, and the clear protective coating)

During the warranty period, the FINISH will be warrantied as follows:

- 2.1 **Resistance to cracking and splitting.** The FINISH will be free of any visible cracking or splitting when observed from a distance of 10 feet (3 m) from the FINISH surface and inspected at a 90-degree angle to the surface.
- 2.2 **Colour stability.** No change in the colour of the FINISH exceeding 5 (five) CIE Lab units measured according to Section 6.3 of the ASTM D2244 standard. Colour change will be measured on the exposed FINISH surface after it has been cleaned to remove oil, grease, or other contaminants. The corresponding values will be compared to those of the original manufactured sample.
- 2.3 **Gloss retention.** The FINISH will have a gloss retention of at least 30% of the original, measured at 60° in accordance with the ASTM D523 standard. Gloss retention will be measured on the exposed FINISH surface after it has been cleaned to remove oil, grease, powder or other contaminants. The corresponding values will be compared to those of the original manufactured sample.
- 2.4 **Adhesion.** The FINISH, whose adhesion is initially measured on reference samples, will not show any detachment inferior to class 4B as per method "B" of the ASTM D3359 standard.
- 2.5 In the event of a FINISH defect:

- 2.5.1 **For three (3) years following the installation completion date:** Maibec Inc. will, at its sole discretion, replace or repair the defective portion of the product or reimburse the defective portion and labour costs up to a maximum of 10 \$ CA per square foot to the buyer or subsequent owner of the building where the PRODUCT is installed, as the case may be.

- 2.5.2 **For the fourth (4th) to fifteenth (15th) years following the installation completion date:** Maibec Inc. will, at its sole discretion, replace or repair the defective portion of the PRODUCT or reimburse the defective portion to the buyer or subsequent owner of the building where the PRODUCT is installed, as the case may be.

- 2.5.3 **For the sixteenth (16th) to twentieth (20th) years following the installation completion date:** Maibec Inc. will, at its sole discretion, replace or repair the defective portion of the PRODUCT or reimburse the defective portion, up to an amount based on the PRODUCT's remaining lifespan, to the buyer or subsequent owner of the building where the PRODUCT is installed. Please refer to the table below for warranty coverage information.

### SECTION 3 - AAMA 2605-13 PAINT FINISH

(The term "FINISH" refers to the primer coat and the AAMA 2605-13 finish coating)

During the warranty period, the FINISH will be warrantied as follows:

- 3.1 **Resistance to cracking and splitting.** The FINISH will be free of any visible cracking or splitting when observed from a distance of 10 feet (3 m) from the FINISH surface and inspected at a 90-degree angle to the surface.
- 3.2 **Resistance to chalking.** The FINISH will not chalk in excess of a numerical rating of 8 measured according to method A of the ASTM D4214 standard.
- 3.3 **Colour stability.** No change in the colour of the FINISH exceeding 5 (five) CIE Lab units measured according to Section 6.3 of the ASTM D2244 standard. Colour change will be measured on the exposed FINISH surface after it has been cleaned to remove oil, grease, powder, oxide film, or other contaminants. The corresponding values will be compared to those of the original manufactured sample.
- 3.4 **Gloss retention.** The FINISH will have a gloss retention of at least 50% of the original, measured at 60° in accordance with the ASTM D523 standard. Gloss retention will be measured on the exposed FINISH surface after it has been cleaned to remove oil, grease, powder, or other contaminants. The corresponding values will be compared to those of the original manufactured sample.
- 3.5 **Adhesion.** The FINISH, whose adhesion is initially measured on reference samples according to Section 8.4 of the AAMA 2605-13 standard, will not peel at a rate inferior to class 4B as per Method B of the ASTM D3358 standard.

## Limited Warranty Extruded Aluminum Planks (cont'd)

### SECTION 4 - WARRANTY TERMS AND CONDITIONS

- 4.1 The "warranty period" for the warranty in Section 1 will be valid for fifty (50) years as long as the abovementioned "Owner" or "Buyer" owns or lives in the property where the product was originally installed.
- 4.2 The warranty in Section 2 will be valid for a period of twenty (20) years after the installation has been completed in accordance with the terms described in Section 2.5.
- 4.3 The warranty in Section 3 will be valid for a period of twenty five (25) years after the installation has been completed.
- 4.4 You must register the product. The warranty is not valid if you do not send in the warranty registration form. Registering the warranty confirms when you purchased the product and helps Maibec Inc. process claims.
- 4.5 This warranty covers the original buyer and only one other owner of the structure where the products have been installed.
- 4.6 This warranty may be transferred (once) from the original owner. To transfer the warranty, submit written notice within 90 days of when the building changed hands. The notice must include the warranty registration number, the building address, the name, and mailing address (if different) of the new owner(s), and the date of the transfer.
- 4.7 Keep your proof of purchase as you will need it when submitting a claim.
- 4.8 Normal atmospheric conditions exclude corrosive or significantly polluted atmospheres, such as, but not limited to, atmospheres contaminated with chemical fumes or ocean spray.
- 4.9 The warranty does not cover damage to the product or finish caused by handling, shipping, workmanship, or installation.
- 4.10 The warranty does not cover damage to the product or finish caused by scratching or abrasion after installation.
- 4.11 The warranty does not cover damage to the product or finish caused by standing water in horizontal installations.
- 4.12 The warranty does not cover damage to the product or finish caused by storage. To avoid damaging your product, store it flat in a dry location. Do not store it in a humid environment.
- 4.13 The warranty does not cover damage to the product or finish caused by improper maintenance. Dust, dirt and other deposits on the product and finish should be cleaned annually with a soft sponge or cloth, water, and mild detergent or soap with a pH between 5 and 9. Avoid using a pressure washer and harsh cleaning or chemical products.
- 4.14 The warranty does not apply to damage caused by natural disasters, falling objects, external forces, explosions, fires, riots, public demonstrations, acts of war, or other similar or different events beyond the control of Maibec Inc.
- 4.15 Claims must be submitted to Maibec Inc in writing within a reasonable timeframe (90 days) after the problem has been identified. Authorization must be obtained before starting any repair or refinishing work. Upon receipt of such notice, Maibec Inc. must be given a reasonable period to inspect and verify the claim.
- 4.16 Maibec Inc's liability under this warranty is limited to repair or replacement at the sole discretion of Maibec Inc.
- 4.17 The warranty on any repaired or replaced product is valid for the remainder of the original product warranty period. All work will be performed by a company or contractor selected or authorized by Maibec Inc. Colour variation between repaired or replaced products and original products will not be considered a defect.

- 4.18 This warranty represents the entire agreement between the parties relating to its subject matter and supersedes any prior agreement, verbal or written, between the parties relating to its subject matter. The limited warranties specify Maibec Inc's full liability for the products they cover. Maibec Inc is not liable for any consequential damages. No person is authorized to make any statements about the warranty on behalf of Maibec Inc except as expressly stated above, and such statements will not be binding on Maibec Inc.
- 4.19 Except as expressly stated above, Maibec Inc. makes no warranties of any kind, express or implied, including but not limited to warranties of merchantability or fitness for a particular purpose. Warranties are valid for the duration of the limited warranty, or the shorter period provided for by local law. These limited guarantees give you specific legal rights, and possibly other rights that vary from region to region.
- 4.20 NOTHING IN THIS WARRANTY SHALL BE CONSTRUED AS A WARRANTY OF THE QUALITY OF THE INSTALLER'S WORKMANSHIP, OR AS REQUIRING MAIBEC INC. TO BE LIABLE FOR UNSATISFACTORY PERFORMANCE DUE TO FAULTY WORKMANSHIP OR INSTALLATION.
- 4.21 All questions relating to the meaning or applicability of this limited warranty will be dealt with under the laws of the province of Quebec and its interpretation is subject to these same laws. Any dispute between the parties in connection with this warranty must be heard by the Quebec City judicial district court, to the exclusion of any other court.

This warranty gives you specific legal rights, and you may also have other rights which vary from province to province. The provisions of this warranty do not prevent the application of any applicable provincial or state law which, in certain circumstances, may prohibit certain limitations and exclusions provided by these warranties.

MAIBEC SHALL NOT BE LIABLE IN ANY EVENT FOR INCIDENTAL, SPECIAL, MULTIPLE, PUNITIVE, INDIRECT OR CONSEQUENTIAL DAMAGES RESULTING FROM ANY DEFECT IN THE PRODUCT(S) PROVIDED, INCLUDING, BUT NOT LIMITED TO, DAMAGE TO PROPERTY OR LOSS OF PROFITS .
